ORDINANCE 16-18 AN ORDINANCE AMENDING ORDINANCE NO. 09-18 OF THE CITY OF PORT CLINTON AND ADJUSTING ACCOUNTS WITHIN THE CITY OF PORT CLINTON

RESOLUTION 18-2 A RESOLUTION IN SUPPORT OF A GRANT APPLICATION TO THE OTTAWA-SANDUSKY-SENECA JOINT SOLID WASTE MANAGEMENT DISTRICT AND AUTHORIZING AND DIRECTING THE CITY ADMINISTRATION TO SUBMIT SUCH APPLICATION, AND DECLARING AN EMERGENCY.

ORDINANCE 18-18 AN ORDINANCE PROVIDING FOR THE ISSUANCE AND SALE OF BONDS IN THE MAXIMUM PRINCIPAL AMOUNT OF \$255,000 FOR THE PURPOSE OF PAYING COSTS OF IMPROVING REAL PROPERTY TO RESTORE AND PRESERVE NATURAL, SCENIC OR OPEN CONDITIONS OF LAND, WATER OR WETLANDS AGAINST MODIFICATION OR ENCROACHMENT RESULTING FROM OCCUPATION, DEVELOPMENT OR OTHER USES, AND DECLARING AN EMERGENCY.
