

**Ordinance 30-18**

**AN ORDINANCE AMENDING ORDINANCE NO. 09-18 OF THE CITY OF PORT CLINTON  
AND ADJUSTING ACCOUNTS WITHIN THE CITY OF PORT CLINTON**
