

#### Who Can Enter

The Greater Port Clinton Area Arts Council (GPCAAC) and the City of Port Clinton "Capture our Community...with a Photograph" context is open to all amateur photographers. Board members of the GPCAAC are excluded from participating.

# Photographer -Copyright

Entries must be submitted by the original photographer. You must be the sole owner of the copyright of any image submitted. Your submission of the photo is your guarantee that you are the artist and copyright holder of the photo.

# Ownership—Use of Photos

Photographers retain the copyright of their photos. By entering the contest, photographers agree to have their submitted photo displayed by the GPCAAC and City of Port Clinton on City Hall walls, website, promotional materials and we may retain copies of photograph for archival purposes without any fee or other form of compensation. Photos may be credited to the photographer named in the entry process. Entries (including non-winning entries) may be selected for display or use in other GPCAAC and City of Port Clinton websites or promotional materials but will never be sold. Entrants retain ownership and all other rights to future use of their photographs.

#### **Number of Entries**

An individual may submit up to ten (10) photographs. Entries may be entered by uploading digital files. All photos must be entered by August 5, 2019.

## **Photo Subject Restrictions**

Photos must be appropriate for posting on a public website or within other publications. Obscene or otherwise questionable content will not be considered. The GPCAAC and City of Port Clinton retains sole discretion as to what constitutes inappropriate content.

# Image File Requirement

Photographs must be submitted in digital format. All digital files may not exceed 4MB (four megabytes), in jpg format and 300 dpi or higher. Images must be an accurate reflection of the subject matter and seen as it appeared, without alteration (other than standard optimization, including removal of dust, cropping, adjustments to color and contrast).

HARD COPY PRINT, SLIDES OR NEGATIVE SUBMISSIONS **WILL NOT BE ACCEPTED** and **WILL NOT BE RETURNED!** The GPCAAC cannot be responsible for lost, damaged, late or faulty uploading connections, jumbled transmissions, unauthorized intervention or technical malfunctions.

#### How to Enter

Each photo entered must be submitted by separate emails.

Digital photos submitted need to be sent to OttawaCountyArts@gmail.com in the following format;

#### Winners

Judges and the contest committee will choose 25 photographs that will be displayed at Port Clinton City Hall. Each photograph will then be voted on by Mayor Mike Snider, City Council Members and Safety Service Director Olen Martin. The winner of the contest will be announced at the GPCAAC Boats, Brushes & Brews event August 10, 2019. There will be one (1) Best of Show who will receive a \$100 Port Clinton Chamber of Commerce Gift Certificate. The 25 photos selected will be used as postcards for Port Clinton.
