### **SECOND READING OF ORDINANCES AND RESOLUTIONS**

**Ordinance 1-20** AN ORDINANCE MAKING APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPEDITURES OF THE CITY OF PORT CLINTON, COUNTY OF OTTAWA, STATE OF OHIO, DURING FISCAL YEAR ENDING ON DECEMBER 31, 2020.

**Ordinance 2-20** AN ORDINANCE TO APPROVE 2020 REPLACEMENT PAGES TO THE PORT CLINTON CODIFIED ORDINANCES AND DECLARING AN EMERGENCY.

**Ordinance 3-20** AN ORDINANCE TO APPROVE THE COMMUNITY HOUSING IMPACT AND PRESERVATION 2020 PARTNERSHIP AGREEMENT BETWEEN THE CITY OF PORT CLINTON AND OTTAWA COUNTY AND TO AUTHORIZE AND DIRECT THE DIRECTOR OF SAFETY AND SERVICE TO EXECUTE THE AGREEMENT AND DECLARING AN EMERGENCY.

**Ordinance 4-20** AN ORDINANCE ENACTING CHAPTER 377 OF THE CODIFIED ORDINANCES OF THE CITY OF PORT CLINTON ENTITLED UNDER SPEED VEHICLES, PROHIBITING THE USE OF UNDER-SPEED VEHICLES, UTILITY VEHICLES, AND MINI-TRUCKS UPON ANY STREET OR HIGHWAY IN THE CITY OF PORT CLINTON AND DECLARING AN EMERGENCY.
