

ORDINANCE NO. 15-20

AN ORDINANCE AUTHORIZING AND DIRECTING THE SAFETY SERVICE DIRECTOR TO ENTER INTO A CONCESSION LICENSE FOR THE LAKEVIEW PARK CONCESSION AREA AND DECLARING AN EMERGENCY

WHEREAS, in the past the City of Port Clinton has entered into agreements for the operation of a concession stand in Lakeview Park during the summer season, and

WHEREAS, the Safety Service Director issued a Request for Proposals (RFP) for the operation of a Concession Area at Lakeview Park and received one responsive proposal to the RFP, which was determined to be appropriate and in the best interest for the City, and

WHEREAS, this Council finds and determines that it is in the best interest of the City to enter into a license agreement for the operation of a concession stand in Lakeview Park, to provide food and beverage service to visitors to the park area.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Port Clinton, County of Ottawa and State of Ohio:

Section 1. The Safety Service Director is hereby authorized and directed to enter into a license agreement for the operation of a concession stand in Lakeview Park with Chris & Stacy Maple (DBA: Lake View Concessions), in accordance with the terms and provisions of the license agreement of file in the office of the Director, but with such changes and modifications therein as shall not be materially adverse to the City, after consultation and advice with the Law Director, and which are approved on behalf of the City by the Director, all of which shall be evidenced conclusively by his execution of the license agreement.

Section 2. The Director, the Auditor, the Treasurer, the Clerk of Council, the Director of Law, and other City officials, as appropriate, are each authorized and directed to take any and all such other actions, including execution and delivery of any further agreements or instruments as are necessary or appropriate to consummate the transaction contemplated by this Ordinance.

Section 3. This Council finds and determines that all formal actions of this Council and any of its committees concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council or committees, and that all deliberations of this Council, and any of its committees, that resulted in those actions were in meetings open to the public, in compliance with the law.

Section 4. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, and for the further reason that this Ordinance is required to be immediately effective so that the Licensee of the Concession Area is authorized to have possession of and to prepare the Concession Area to

commence operating for the 2020 summer season; **wherefore**, this ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
