Old Business

Chief Rob Hickman

All new police vehicles are on-site. Currently three of the four are on the road. Received notification that the canine insert will be shipped by the end of March. The new and old canine vehicle will be taken to be worked on (canine insert, radios, etc.) the first of April.

ORDINANCE 4-20 (under-speed vehicles)

Mrs. Shenker stated that if the schools or City is using these for jobs this ordinance does not apply. Neither of these entities are to drive on the streets.

Ms. Phillips inquired from Chief Hickman whether mowers can be driven on the road from one property to another. Chief Hickman advised they would need the triangle (just like farm equipment).

The Police Department has remodeled the conference room due to limitations that became apparent during the Haley Dilly investigation. Work should be completed on March 12, 2020.

The interrogation room IRecord system is on its way – the CAT five lines will be installed on March 11, 2020.

Due to the Harley Dilly investigation, the drug task force car has over 180,000 miles. The Police Department has purchased a 2017 vehicle that will be predominantly used for the Ottawa County Drug Task Force.
