Mr. Below move to amend Ordinance 9-21, 719-.01, Section 1, subsection (e) to read as follows"; seconded by Mr. Tarolli.

"Downtown Waterfront Overlay District, Central Business District, and Manufacturing Districts located west of Monroe Street and north of the rail line" means the geographical area outlined in Exhibit A;"

and, 719.08, subsection (a) to read as follows: "Street Vendors shall not conduct business in the Downtown Waterfront Overlay District, the Central Business District, and the Manufacturing Districts located west of

Monroe Street and north of the rail line."

And inserting as Exhibit A, the map describing the overlay districts in subsection e) as previously stated.
