Registration is required if you live within the City Limits or will be conducting business including owning any type of rental property. Residents, Landlords – (Long Term, Short Term, Seasonal etc.) & anyone conducting business within the city limits is required to file a city income tax return each year. If you are a business, a business questionnaire is also required to be completed. A city income tax return is required to be filed each year by April 15 unless the date has been changed by the Internal Revenue Service. All information is confidential. (Persons under the age of 18 years are not subject to Port Clinton Income Tax, however, proof of age must be provided).

The City of Port Clinton requires at least 90% of your total tax liability be withheld or paid in equal installments, or be subject to a penalty. The 90% tax liability is due each year by December 15<sup>th</sup>. A system of quarterly declarations of estimated income tax is available to those persons not subject to withholding by their employers or those who have additional income from other sources. You may contact the Income Tax Department for these forms or visit our website at <u>www.portclinton.com</u>. Thank you for your cooperation. The current tax rate in the City of Port Clinton is 1.5%. If you pay another municipality tax, 0.5% courtesy credit is given in the City of Port Clinton.
