AUDITOR'S REPORT	Mr. Below provided a copy of the Financial Report for February 2022. This evening is the second reading for Ordinance 6-22 Appropriations for Fiscal Year ending of December 31, 2022. At the third reading there will be an amendment submitted due to the increase in oil and gas prices for City vehicles.

	Earlier today, Mr. Below and Mr. Colston met with Chief Dave Scott to discuss vehicle replacement plan. Within the current police budget, there is a \$95,000 line item for new vehicles.
POLICE CHIEF	Chief Scott provided a copy of his proposal to obtain six police car to Council members.
	Present day six of the vehicles that are in service have over 90,000 to- 118,000 miles on them. Two of these patrol vehicles in the last six months the engines expired and are out of service. Currently three officers are without a personal patrol vehicle, plus four part-time officers that share these vehicles.
	Initially the City was proposing to purchase two new police vehicles each year and rotate the older ones out of service.
	After some research, it benefits the City to lease six vehicles for the next three years. Leasing a patrol vehicle is not like the traditional lease for you and me. There is no pay off and we do not turn the vehicle back in; we just finance the vehicles. The only negative to a lease we will have to pay a bit of interest, approximately \$4,000 a year.
	In 2021, the maintenance cost on patrol vehicles were \$26,827.06.
	If we proceed with the lease program, it will be mid-summer before vehicles would be available by the dealer. The lowest bid for these vehicles is from Bauman Auto Group in Portage Township.
