ORDINANCE NO. 14 - 22

AN ORDINANCE AUTHORIZING AND DIRECTING THE DIRECTOR OF SAFETY AND SERVICE TO ENTER INTO A CONCESSIONS LICENSE AT LAKEVIEW PARK AND AT THE CITY BEACH WITH LAKESHORE CONCIERGE AND DECLARING AN EMERGENCY

WHEREAS, in the past the City of Port Clinton has entered into agreements for the operation of a concession stand at Lakeview Park during the summer season; and

WHEREAS, previous agreements were confined solely to the use of the concession stand that was bypassed by visitors on their way to the beach; and

WHEREAS, Lakeshore Concierge proposed adding equipment rentals to the concession stand at Lakeview Park, such as: beach chairs, sports equipment, kayaks, and other beach equipment, in addition to food and beverage service, to attract visitors on their way to the beach; and

WHEREAS, the proposal includes setting up a temporary pop up tent at the west end of the City Beach, to be set up and taken down daily, and used to provide food and beverage service and equipment rentals to visitors at the beach; and

WHEREAS, this Council finds and determines that it is in the best interest of the City to enter into a license agreement with Lakeshore Concierge for the operation of concessions at Lakeview Park and at the west end of the City Beach, to provide food and beverage service and equipment rentals to visitors to the park and the beach.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Port Clinton, County of Ottawa and State of Ohio:

- **Section 1.** The Safety Service Director is hereby authorized and directed to enter into a license agreement with Lakeshore Concierge, in accordance with the terms and provisions of the license agreement on file in the office of the Director.
- **Section 2.** The Director, the Auditor, the Treasurer, the Clerk of Council, the Director of Law, and other City officials, as appropriate, are each authorized and directed to take any and all such other actions, including execution and delivery of any further agreements or instruments as are necessary or appropriate to consummate the transaction contemplated by this Ordinance.
- **Section 3.** This Council finds and determines that all formal actions of this Council and any of its committees concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council or committees, and that all deliberations of this Council, and any of its committees, that resulted in those actions were in meetings open to the public, in compliance with the law.

Section 4. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, and for the further reason that this Ordinance is required to be immediately effective so that the Licensee of the concession areas is authorized to have possession of and to prepare the concession areas to commence operating for the 2022 summer season; **wherefore**, this ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
