## ORDINANCE 28 - 22

AN ORDINANCE AUTHORIZING THE DIRECTOR OF SAFETY AND SERVICE TO ENTER INTO AN AGREEMENT WITH GREENSPOT JC, LLC, A LIMITED LIABILITY COMPANY, TO INSTALL, OPERATE, MANAGE, AND SERVICE ELECTRIC VEHICLE (EV) NETWORKED CHARGING EQUIPMENT IN THE CITY OF PORT CLINTON AND DECLARING AN EMERGENCY

WHEREAS, Electric vehicles are increasing in popularity and so is the need to provide electric vehicle charging stations (EV Stations) to people in areas where people travel, shop, dine, and work; and

WHEREAS, Electric vehicles can be recharged wherever they make their home and as more electric vehicles hit the market and are used more broadly, new public charging locations will be required for people to have access to; and

WHEREAS, the City of Port Clinton has many visitors that come to the City for its beach, dining, entertainment, shopping, work, and other activities; and

WHEREAS, the City of Port Clinton needs to install public EV Charging Stations to provide charging locations throughout the City to accommodate the needs of its residents and visitors who need a place to charge their electric vehicles while in the City; and

WHEREAS, this Council finds that installing public EV Charging Stations in the City of Port Clinton would be beneficial to the City, its residents, and its visitors.

WHEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PORT CLINTON, OTTAWA COUNTY, OHIO:

Section 1. The Director of Safety Service is hereby authorized and directed to enter into an Agreement with Greenspot JC, LLC, A New Jersey limited liability company to install, operate, manage, and service electric vehicle (EV) networked charged equipment in the City of Port Clinton.

Section 2. The Director of Safety and Service, the City Auditor, the Law Director, and other City officials, as applicable, are each authorized and directed to sign any transcript certificates, financial statements, and other documents and instruments and to take such actions as are necessary or appropriate to consummate the transaction contemplated by this Ordinance.

Section 3. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 4. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, and for the further reason that this Ordinance is required to be immediately effective in order begin the process of locating appropriate EV Station sites in the City, wherefore this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
