#### SECOND READING

#### Ordinance 4-23

AN ORDINANCE PROVIDING FOR THE ISSUANCE AND SALE OF NOT TO EXCEED \$4,500,000 OF NOTES, IN ANTICIPATION OF THE ISSUANCE OF BONDS, FOR THE PURPOSE OF PAYING COSTS OF IMPROVING STREETS BY RESURFACING, GRADING, DRAINING, PAVING AND MAKING OTHER IMPROVEMENTS AS DESIGNATED IN THE PLANS APPROVED OR TO BE APPROVED BY COUNCIL, AND DECLARING AN EMERGENCY.

Auditor Gabe Below discussed the Fiscal Officer's Certificate provided to City Council on January 23, 2023. Ordinance 4-23 authorizes the issuance of bond anticipation notes, not to exceed \$4,500,000, for the purpose of paying costs of improving streets as part of the first phase of the City's infrastructure improvement project. Mr. Below requested Ordinance 4-23 be passed as an emergency measure upon its second reading.

Mr. Tarolli moved to waive the three required readings on Ordinance 4-23, seconded by Mr. Hovis.
