LAW DIRECTOR REPORT Ordinance 31-23, is modifying our codified ordinances. This ordinance mimics the Ohio Revised Code (ORC). The City of Port Clinton is a statutory city and we follow the Ohio Revised Code. There are two big changes:

- Section I under Income Subject to Net Profit Tax; Alternative Apportionment Qualifying remote employee or owner.
- Annual Return Extensions to file the annual return.

All the amendments are in bold italics. Please consider passing on the first reading due to the ORC goes in effect on January 1, 2024.

Mrs. King inquired if minors not having to pay City Income Tax is included?

Ms. Shenker advised that the City has always had that policy. There was no need to add that to Ordinance 31-23.

SAFETY SERVICE REPORT

H2O Program: Nine current participants have not applied to be part of the H2O program in 2024; the deadline was December 1, 2023. Mr. Colston inquired if Council would be willing to extend the deadline date; if so to when? If we get all nine spots filled the H2O program budget will need an additional \$1350.00. In the past Council has approved transfering funds to the H2O Program.

We have received three new applicants for the H20 program in 2024; have six remaining spots available.

Mr. Tarolli moved to allow a deadline extension to December 31, 2023, and to increase the H20 Program budget to \$1350.00; seconded by Mrs. Gillman.

Ordinance 32-23; Republic Services contract. The former Safety Service Director contracted with Republic Services for five years with three one year options. Republic Services provided the price for

2024; \$24.40 month (up from \$23.02 month). A Teams meeting is scheduled tomorrow to discuss some discrepancies in billing to some community members. There will also be continued discussion of Republic Services using lighter trucks with the Infrastructure Project starting in 2024. If they are not able to provide what we request the City will need to go out for bid for trash removal for the City in 2025.

Mr. Colston asked that Council consider adopting Ordinance 32-23 at the first reading; due to having to advise Republic Services of wanting to extend the contract one year within 90 days of our current contract end date of March 31, 2024.

Mr. Tarolli inquired if recycling is truly recycled?

Mr. Colston advised that he was told that 60% is recycled and 40% goes to the dump. This is due to contaminated items (liner in pizza boxes with grease, lids not being the correct plastic, etc.). The City may consider not continuing recycling pickup; it would eliminate 24 trucks on newly paved streets. Will look into further this coming year. The containers that are in front of City Hall are provided by OSS Solid Waste District will remain. Please consult your constituents to get their opinion on taking their recycling to the City Hall parking lot.
